Mobile Transfer Client (MTC) for Globalscape EFT™

BYOD Made Simple

The Mobile Transfer Client (MTC) mobile app is a core feature of Globalscape EFT that allows your employees to use their own mobile devices to access corporate data, while keeping your network secure within the organizational boundaries. With MTC, your organization has the right balance of employee productivity, efficiency, and corporate data security, allowing employees to be on the move with secure access to files stored on EFT.

Security and IT Control

MTC keeps files safe and secure while in transit and while at rest. MTC ensures that only authorized personnel can access information, and encrypts files in a storage vault for users that need to work offline. IT has full centralized control over all policies that MTC enforces when a user connects to EFT, such as saving the profile password, saving files to the MTC vault, sharing files as email attachments, and more. Logging can be used to troubleshoot any problems with the MTC app.

New-user on-boarding is as simple as a single click. When you set up EFT accounts to use MTC, EFT will send a link to the user.

After the MTC app is downloaded and installed on the user devices, they can click a link in their email, and their profile will be created and logged in (if you have sent the username and the password with the link).

Depending on the permissions defined for the account in EFT, users can upload, download, preview, open in an external viewer, add to vault, share, rename or delete files, and create folders.

- View detailed transaction logs
- Email logs to your administrator

- Disallow password saving (global option)
- Custom/branded profile icons (optional)
- Choose light or dark theme

Files Listings and Transfers

- View up to 10,000 files in a directory listing
- Transfer files up to 3GB in size
- Transfer multiple files concurrently
- Pause and resume transfers
- Automatic resume of system-paused transfers
- Resume partial transfers from point of failure
- Download files to a separate secure repository for offline access
- Download files and open them using the built-in file viewer (Only certain file types are supported.)
- Open text, log, and other ASCII files in the internal text viewer
- Download files, then open in an external program
